Instructions:

Check 'Yes', 'No', or 'Don't Know' on each question below. This questionnaire should be administered to children from **6 to 72 months of age** at well-child visits.

Testing Recommendations/Requirements:

- Blood lead testing is **recommended** on all children at **1 and 2 years** of age and up to 72 months if never been tested.
- All children enrolled in Medicaid are **required** to be tested at ages 1 and 2 and up to 72 months if not previously tested. All children entering Head Start are **required** to be tested.
- **All children should be tested when there is a "Yes" or "Don't Know" response on any question below.**

7	Has this child been exposed to lead from certain items such as cosmetics, candies, spices, jewelry, folk medicines, home remedies or glazed pottery that have been imported from a foreign country such as Mexico, Central or South America, China, India, or Pakistan?			
8	Does this child frequently try to eat or mouth non-food items?			
9	Does this child live with someone who has a job or hobby that may involve lead such as jewelry making, plumbing, furniture refinishing, working with lead solder or stained glass, reloading or casting bullets, target practice, hunting, fishing, building renovation or repair, automobile batteries, radiators, or bridge construction.			
10	Has this child ever lived near a factory or operation where lead may have been present or used (for example a mining/milling operation, a smelter, a paint, ammunition or battery factory, or an oil refinery)?			
11	Does this child eat hunted game meat that may have been shot by lead bullets?
